The solution supports all event types including injuries & near misses, as well as a range of impact types like property damage, process loss, motor vehicle, and environmental impact.

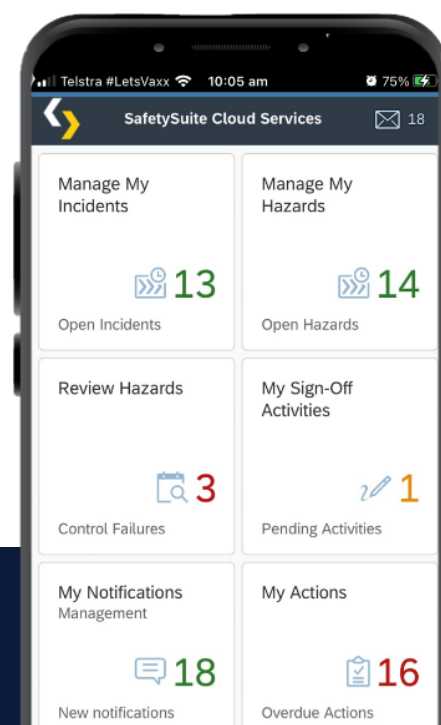
Process Consistency

You then drive accountability by assigning the corrective actions and tasks necessary to remedy the immediate situation. These tasks are monitored continually, issuing reminders or escalating the task to maintain compliance.

As an incident nears its closure, SafetySuite can ensure that all the requested corrective actions are closed out, lessons and knowledge are shared between your business units and any feedback into your risk and hazard processes has been adopted.

NOTIFICATIONS

Get the right team involved.

As an incident occurs, a range of people must be notified of the event. SafetySuite Incident Management reads the SuccessFactors Organisational structures and distribution lists directly to determine the managers that need to be involved.

If external parties or Authorities such as WorkCover or ACC are also involved, then the legally required formatted documents can be produced automatically from the system.



PROCESS EFFICIENCY

Constant monitoring to ensure compliance.

When your team is tasked with a range of activities to respond to an event, it's vital that each task is completed both effectively and in a timely manner. SafetySuite will allow you to track these tasks for completion and escalate them when they are out of compliance.

SafetySuite Incident Management comes with a library of standard process-based reports to assist with the monitoring of internal SLA's. Average and targeted times for all aspects of the incident are tracked.

Examples include the time from:

- Incident to initial report
- Initial report to investigation start
- Start to completion of investigation
- Completion of actions
- Initial report to incident closure
- Overall process compliance
