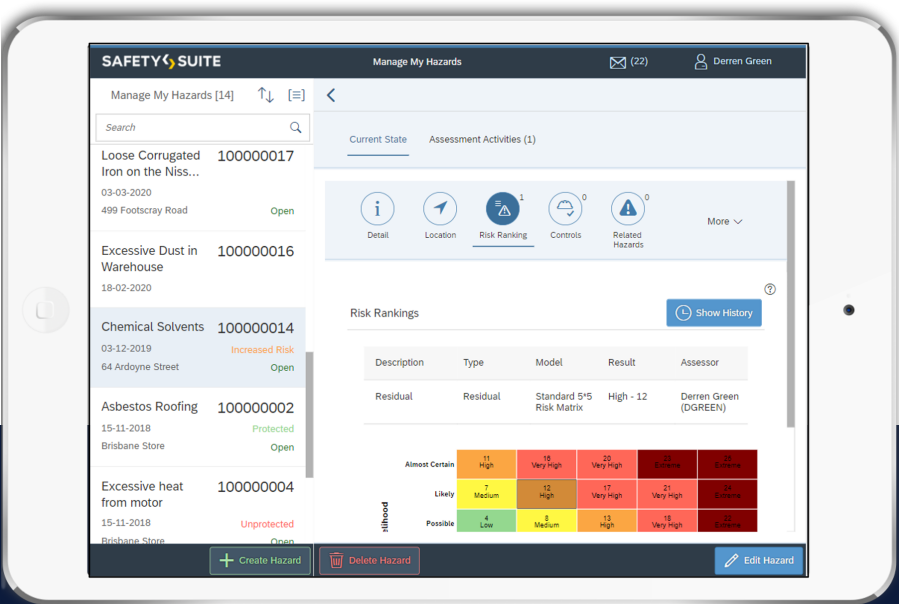
Drive Accountability
